**Re: Clarification on Unusual Price Movement of PhilWeb Corporation Shares**

Gentlemen,

We acknowledge receipt of your inquiry dated 24 March 2025 regarding the unusual price movement in the trading of PhilWeb Corporation (“WEB”) shares, wherein the share price declined from PhP3.29 to PhP2.31 per share at 13:57:35 PM on the same day.

The Company notes that the price fluctuation may possibly correlate to market reactions following the publication of the news article entitled “Hindi bet ni Bossing! Playtime ain’t interested in Gregg Araneta’s sizzling PhilWeb stock”, which was published on Bilyonaryo.com on 21 March 2025.

We reiterate the disclosure previously made to the Philippine Stock Exchange that PhilWeb Corporation (“PhilWeb” or the “Company”), through its representatives, management, or members of its Board of Directors, has had no interactions, communications, or engagements of any nature with any individual or entity representing the Playtime Group. Furthermore, the Company is not aware of nor involved in any discussions, negotiations, or transactions related to the purported backdoor listing by Playtime through PhilWeb. The Company has also had no contact with Bilyonaryo.com or its representatives before publication of said article, nor has responded to such, outside that of the reply sent to the Philippine Stock Exchange.

Should there be any material developments requiring disclosure, the Company will promptly inform the Exchange in accordance with applicable regulations.
